





Rules & Regulations

- Fee is to be deposited quarterly in advance. After the last date, late charges will be applicable.
- 5% rebate on Paying Whole Fee of the session on School Bus Fees.
- Fee once deposited cannot be refunded and is not transferable either.
- 25% Seats for Economically weak students are available as per the U.P. government rules.
- One month written notice should be given in advance by the parents/guardian when withdrawing the student from the school.
- The parents are responsible to inform the authorities, if their ward is unwell.
- In cases of illness, the child shall be given first aid medical treatment by the doctor/medical
 officer authorized by the school. In case where additional specialized treatment is required the
 student herself/himself shall be responsible for bearing the medical and transportation
 expenses.
- In case the student remains absent for a period of more than ten days without any application or information to Class Teacher/Prinicipal, also in case of non payment of fee in 60 days of due date, the name of the student will be Struck off from the School.
- Transport facility is also available in selected areas. Fee applicable shall be paid by the students.
